

Terms and Condition of Deployment of Doctors on daily wages as Medical Officer

01. Qualification: -

- i) For Graduate Doctors- MBBS or its equivalent degree in Allopathic system of Medicine.
- ii) For Specialist Doctors: MD/MS/Diploma/DNB in Clinical Subjects Medicine/Obstetrics and Gynecology/Pediatrics or any subject decided by management.
- iii) Preference will be given to Doctors having certificate of AFIH (Associate Fellow of Industrial Health)

02. Permanent Registration of Qualification Degree -Chhattisgarh Medical Council Raipur.

03. Experience: - Nil however

- i) Preference will be given to post graduate Doctors or AFIH.
- ii) Preference will be given to experience of work in Govt. Organization or Public sector undertaking or reputed bedded private hospital.
- iii) Preference will be given to longer work experience.

04. Terms & Conditions: -

- i) Appointment will be for 60 days from the date of joining including off or till regular appointment of Medical officer.
- Services of the Doctors can be taken both at Occupational Health Center and Hospital as per requirement. Doctor should treat patient as OPD, IPD and Emergency case & provide First Aid. Doctor have to do medical examination of Plant workers, training for First Aid, Education activity on subjects like AIDS, TB, Occupational disease as and when required and have to actively participate in Awareness & Health Camps and delegated official work.
- iii) Doctor will be under administrative control of Addl. Chief Medical Officer ABVTPS, Marwa and should follow his instruction for duties and off.
- iv) Duties can be allotted general shift as well as 08 hourly shift or emergency duty as per requirement.
- v) Leave, conveyance and accommodation facilities from CSPGCL not permitted except weekly off.


 If accommodation provided from CSPGCL than market rate will be recoverable from candidates.
- vi) Payment will be on prescribed daily wages for working days. (Rs. 3700/- for Graduate Doctors and Rs. 5600/- for specialist doctor)
- vii) Income tax and other contribution will be deducted as per CSPC rules & prevailing State/Central Govt. rules.
- viii) Doctor should comply all statuary requirement pertaining to OHC and Hospital in relation to Environment, Labour Law, Factory Rule and CG Nursing Home and Clinical Establishment Act etc.
- ix) Damage to any Hospital or OHC property done due to inadvertent action by the deployed doctors will be recoverable from wages.
- x) Doctor's behavior should be good towards to public and fellow officials.
- xi) Medical facility can be availed only available at CSPGCL Hospital Marwa for self only. No medical reimbursement and referral facility will be permissible.
- xii) Traveling Allowances permissible for travel on account of CSPGCL works at the rate prescribed for class-II Medical Officers on approval of competent authorities.
- xiii) Any kind of private practice is not allowed within CSPGCL Plant, Colony and Hospital Campus.
- xiv) Male or Female doctors will be appointed as per requirement and CSPGCL reserve right for selection.

5. Other Conditions

- (i) Duties and Responsibilities: The appointee shall work as Medical Officer (Daily Wages) shall be posted at ABVTPS, CSPGCL Marwa District- Janjgir-Champa (C.G.)
- (ii) Appointee shall have to join the duty within 15 days from the date of issue of appointment order.
- (iii) The appointee shall be posted under the administrative control of the Add. Chief Medical Officer ABVTPS, CSPGCL Marwa.
- (iv) The appointee shall have 06 days working in a week, duties would be in shifts of 48 hours per week schedule in colony hospital and OHC.
- (v) The appointee shall not be entitled for accommodation.
- (vi) The appointee shall not be entitled for reimbursement of medical expenses. However, he may avail the medical facility available at Dispensary/Hospital of Chhattisgarh State Power Companies.
- (vii) The appointee will not be entitled for any kind of advances like House Building Advance, Motor Cycle/Car/Computer Advance etc. during the contract period.
- (viii) Income Tax and other deduction as may be applicable shall be deducted at source by company rule.
- (ix) The Contract shall be terminable by company at any time.


