# ENGAGEMENT OF GRADUATE /DIPLOMA ENGINEERING APPRENTICE TRAINEES UNDER APPRENTICES ACT, 1961 (As amended from time to time)

INDIAN PORT RAIL & ROPEWAY CORPORATION LIMITED (IPRCL) is a first of its kind Joint Venture Company (JVC) between 11 Major Ports under the Ministry of Ports, Shipping and Waterways (Formerly Ministry of Shipping) holding 90% of equity capital and Rail Vikas Nigam Limited (IPRCL) under Ministry of Railways holding 10% of equity capital, incorporated with the objective to provide efficient rail evacuation systems to Major Ports and for enhancing their capacity and throughput. The company was registered on 10th July 2015 as a Public Limited Company under the Companies Act, 2013. The Company is under the Ministry of Ports, Shipping and Waterways (Formerly Ministry of Shipping), Government of India.

Applications are invited from eligible candidates for undergoing one year of Graduate/ Diploma Engineering Apprenticeship Training on All India basis under Apprentices Act, 1961 (as amended from time-to-time) in the trade as mentioned below:

(ii) The decision of the Management shall be final and no appeal will be entertained.

#### (A) General Conditions:

1. **Age Limit:** Maximum 23 years as on last date of receiving of applications in IPRCL Corporate Office, Mumbai.

#### 2. Educational Qualification:

At least 60% in aggregate of all years & semesters in Degree/Diploma in Engineering granted by a Statutory University in relevant discipline. 55% in aggregate of all years & semesters in Degree/Diploma in Engineering for candidates belonging to SC/ST categories.

3. Training Duration: One year.

- 4. **Reservation & Concession:** Relaxation in upper age limit 05 years for SC/ST and 03 years for OBC (Non-Creamy layer).
- 5. Candidates whose results are awaited need not to apply.
- 6. Candidates having job experience of one year or more will not be eligible.
- 7. Candidates should not have undergone Apprenticeship Training earlier or pursuing Apprenticeship Training under the Apprentices Act, 1961 in any organisation.
- 8. Candidates who have passed out Degree / Diploma in Engineering (in respective trade) on or after 01.01.2024 will only be eligible to apply. The date mentioned on the result sheet will be considered as relevant date for determining the eligibility of the Candidate.

Hospitam

 Candidates must have registered themselves on National Apprenticeship Training Scheme (NATS) Portal and should have a valid Regn./ID Number of NATS that will have to be mentioned in the application form at appropriate place.

10. Employment in IPRCL: Candidates shall have no claim whatsoever for any extension of

training and/or employment in IPRCL.

#### (B) Selection Procedure:

Shortlisting of candidates will be done based on the percentage of marks obtained in the prescribed qualification as applicable to the respective disciplines and Merit List will be prepared.

No Interview will be conducted. Selected Candidate will be intimated by e-mail or through post/courier.

#### C) Travel Expenses:

No travel expenses are admissible during apprenticeship training period.

#### D) Boarding / Lodging:

Boarding or lodging will not be provided by IPRCL during the apprenticeship training period.

#### E) Important: Documents to be attached with application:

- a) Self –attested copy of Matriculation Certificate.
- b) Self-attested copies of <u>Degree / Diploma Certificate</u> and <u>mark-sheets</u> of all the semesters for all the years in support of qualification in the respective trade.
- c) Self-attested copy of document of respective College / University regarding CGPA to percentage conversion.
- d) Self –attested copy of NATS Registration.
- e) Self –attested copy of Caste Certificate (in case belonging from reserved category).
- f) Self-attested copy of Photo I.D. proof and address proof (Passport/Aadhaar card/Driving License/PAN card/ Voter I. Card) issued by Central/State Govt.

#### F) IMPORTANT NOTES:

- i. Applications not conforming to the prescribed format or incomplete in any respect or without self-attestation listed above shall be summarily rejected.
- ii. The responsibility of establishing the eligibility for the Graduate / Diploma Apprentice without any doubt shall be that of applicant by way of attaching requisite documents. The process of scrutiny of applications/documents does not involve contacting applicant or collection of additional documents from applicant at any stage.
- iii. In case information furnished in the application format or the Certificates/testimonials are found to be false or incorrect, candidature of such applicants are liable to be cancelled at any stage of the selection or thereafter, besides such other penal action as deemed fit.
- iv. Applicants should clearly note that IPRCL will in no case be responsible for non-receipt of their application or any postal delay in receipt thereof on any account whatsoever.
- v. Management reserves the right to cancel/ restrict/ enlarge/ modify/ alter the selection/ engagement process at any stage, without issuing any further notice or assigning any reason thereafter.
- vi. In case it is detected at any stage of engagement that a candidate does not fulfil the eligibility norms and/or that he/she has furnished any incorrect / false information / certificate / documents or has suppressed any material fact(s), his/her candidature will stand cancelled. If any of these shortcomings is/are detected even after engagement, his/her Contract is liable to be terminated.

- vii. IPRCL has the right to increase or decrease the number of Apprentice advertised or cancel entirely or partially the advertisement/ Notification at any stage without assigning any reason and the decision of IPRCL shall be final in this regard.
- viii. Any resulting dispute arising out of this advertisement shall be subject to the sole jurisdiction of the Courts situated at Mumbai only.
- ix. Canvassing in any form will be a disqualification.
- x. Communication shall be sent at the **Present Address** mentioned by the Candidate in the application form.


#### G) How to apply:
