N.B: Appointment with regard to retired Judicial Employees is subject to the following conditions for the above posts

The following retired Judicial Ministerial Officers are eligible for re-employment for the following posts.

Sl.No	Name of the Post	Eligibility
1	Junior Assistants	Ministerial officers who retired as Junior Assistants/ Senior Assistants
2	Personal Assistant	Ministerial officers who retired as Stenographer
3	Typist	Ministerial officers who retired as Typists/copyists/Junior Assistants who are proficient in typewriting and having requisite qualifications

- 1 Ministerial officers who have retired on attaining the age of superannuation and who have not attained the age of 69 years.
- 2 Ministerial officers having satisfactory record of service.
- 3 The candidates have to produce medical fitness certificate and should be physically and mentally fit to hold the post. The term of re-employment will be determined from time to time by the High Court.
- 4 The employees who were dismissed, removed, compulsorily retired or made or made to seek retirement are not eligible for re-employment.
- 5 The employees who are re-employed shall be entitled to such consolidated remuneration as may be determined from time to time by the Government/High Court.
- 6 Those who are re-employed shall be required to discharge their duties sincerely courteously and honestly to the satisfaction of the presiding officers.
- 7 The services of the re-employed employees are liable to be terminated at any time without assigning any reasons and without any notice and the appointment is purely temporary and on adhoc basis.
- 8 On appointment the appointees shall enter into an agreement with the concerned unit head initially for a period of one year, subject to renewal for a further period from time to time at the discretion of the unit head.
- 9 The applicants should submit their service certificates.
