Merit Lists will be prepared on the basis of Total Marks obtained by the Employees in above mentioned parameters. If same marks are obtained by more than one candidate in the selection criteria, their merit shall be decided by the date of appointment and subsequently the date of birth (i.e. senior in age will be the senior in merit list).

- 2. Employees who are originally placed in higher grade are not eligible to apply, however, employees in the same grade or below grade are eligible to apply against this internal notification; subject to fulfilment of other eligibility criteria as per the Cadre Scheme.
- 3. Only regular and permanent employees of the Company may apply. Employees, whose designation has included Trainee, shall not be eligible.
- 4. Employees not having minimum ACR as "GOOD", for the year 2024-25 shall not be considered eligible to apply.
- 5. Vigilance/ Departmental Clearance of Employees should be "Clear".
- 6. The cut-off date for the minimum qualification and eligibility as per cadre scheme will be date of issuance of Internal Notification.
- 7. Restricted Category: Management reserves the right not to consider the Employees working in statutory capacities. **Such employees need not apply**.

- 3. The Employees posted in various Colliery/ Unit/Area/ Establishment of ECL shall submit their filled in application form, enclosing the relevant self-attested documents (education certificates, caste certificate, Id card, experience certificates if any, etc.), to the Personnel Manager of Colliery/ Unit/ Establishment/ Workshop within 10-08-2025 (Afternoon), who shall verify the submitted details and documents from the Service Files and originals of the Employees and certify the details of the applications received and make necessary entries in Part-B (of Annexure-I) and shall submit it to the concerned Area Personnel Managers.
 - The concerned Area Personnel Managers shall send the consolidated details of all the applicants of their concerned Area to Dy GM(HR)/HOD(Rectt & Empl), ECL HQ in the prescribed Excel Format(will be sent through email) with comments/remarks as Eligible or Not Eligible within 18-08-2025. (Excel format shall also be sent at the email: bhartiecl@gmail.com).
- 4. The Employees posted at ECL HQ would be required to submit their filled in application form enclosing the relevant self-attested documents (education certificates, caste certificate, Id card, etc.) duly forwarded by their GM/HOD of their concerned department, to the HoD (HR/Wage Board Establishment), P&IR Department, ECL HQ well before the last date of submission which is 10-08-2025 (Afternoon).
 - HoD (HR/Wage Board Establishment) shall verify the submitted details and documents from the Service Files and originals of the Employees and certify the details of the applications received and make necessary entries in Part-B and shall send the details of all the applicants to Dy GM(HR)/HOD(Rectt &Empl), ECL HQ in the prescribed Excel Format with comments/remarks as Eligible or Not Eligible within 18-08-2025. - 5. All applications must be forwarded along with the ACR for the year 2024-25. Since the ratings of the ACR shall be compulsory for initial selection process.
