General terms and conditions for Post-Doctoral Fellowship

- **Research Fellowship @ Rs. 1.08 Lakh/Month**
- Contingency- Rs. 1 Lakh for 1 year (on re-imbursement and pro-rata basis depending on the period spent under the award). The claim would be submitted by the awardee through respective institution to PhD Cell in prescribed format.
- The PDF applicant should be an Indian citizen.
- The PDF applicant must have obtained PhD degree from a recognized University with first class (in terms of grades, etc.) in all preceding levels and a good academic record throughout.
- The PDF applicant should have completed PhD within the past 5 years on the last date of submission of application to the institution.
- The upper age limit for the fellowship is 40 years on the date of submission of application to the eligible participating institution.
- Preference would be given to the PDF applicants who have active industry linkages and their research proposal is directed towards industry specific problems.
- **The research proposal of the PDF applicant, to be submitted to the institution, should define clear objectives, outcomes and deliverables against the award.**
- PDF applicants currently in regular employment will not be considered. However, scientists or researchers with temporary positions in academia or research institutions would be considered however, they would be required to relinquish their current roles if selected for the fellowship.
- PDF applicants should not have completed their PhD at the same institution where the PDF fellowship is to be awarded.
