The Maharashtra Electricity Regulatory Commission has decided to fill up the post of Chairperson and Independent Member at various location, under Section 42(5) of the Electricity Act, 2003, The appointment shall be subject to and in accordance with the provisions of the Act and the Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Ombudsman) Regulations, 2020 and MERC (Consumer Grievance Redressal Forum & Electricity Ombudsman) (First Amendment) Regulations, 2024 and the applicable clauses of those Regulations shall govern the appointment, terms of services and functioning.

**A) Qualification of Chairperson:**

**1. Pre-requisites & other Conditions:**

- a) The Chairperson of the Forum shall be a retired senior judicial officer; or a retired civil servant not below the rank of an Additional Collector or equivalent; or a retired Principal of a reputed Engineering college; or a retired Professor of the Electrical Engineering Department of a reputed institute; or a retired senior electrical engineer of the Government:
- b) The Chairperson shall preferably have working knowledge of the vernacular language of the State of Maharashtra.

**2. Period of Contract**

As per the terms of Regulation 4.5 of MERC (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulation 2020, the Chairperson of the Forum shall hold office for a fixed term of three (3) years. The tenure of a Chairperson may be extended by the Commission for a further period not exceeding two (2) years subject to an overall age limit of sixty-five (65) years.

**3. Remuneration & Perquisites:**

- a) Monthly remuneration for Chairperson will be as mentioned in the Table 1 above.
- b) Statutory Taxes will be deducted at source.
- c) The remuneration shall be inclusive of allowance such as sitting fees, honorarium and all other allowance such as conveyance allowance, telephone charges etc.
- d) For holding the additional charge of Chairperson or Independent Member of other CGRF, 5% additional remuneration and the TA/DA at the rate as applicable to the Chief Engineer or equivalent shall be applicable.

**B) Qualification of Independent Member:**

**1. Pre-requisites & other Conditions:**

- a) Independent Member shall have experience of working for at least ten (10) years on matters concerning consumer Grievances.
- b) Candidate shall be well conversant with Marathi language.
- c) Candidate recommended by registered Voluntary Consumer Protection Organisation/registered NGO's in the area working on the matters concerning consumer grievances or Chairperson CGRF, will be preferred.

- d) The Member shall not have been in the employment in any capacity under, or agency of, the Distribution Licensee or provided consultancy services to electricity consumers for a minimum period of three (3) years prior to being appointed as member of the Forum:
- e) Preference shall be given to a representative of a registered voluntary consumer protection organization or Industrial Association and preference shall be given to a person who resides in the same area of CGRF Location mentioned in Advertisement.

**2. Period of Contract**

As per the terms of Regulation 4.5 of MERC (Consumer Grievance Redressal Forum & Electricity Ombudsman) Regulation 2020, Independent Member of the Forum shall hold office for a fixed term of three (3) years. The tenure of Independent Member may be extended by the Commission for a further period not exceeding two (2) years subject to an overall age limit of sixty-five (65) years.

**3. Remuneration & Perquisites:**

- a) Monthly remuneration for Independent Member will be as mentioned in Table 1 above
- b) Statutory Taxes will be deducted at source.
- c) This remuneration shall be inclusive of allowance such as sitting fees, honorarium and all other allowance such as conveyance allowance, telephone charges etc.
- d) For holding the additional charge of Chairperson or Independent Member of other CGRF, 5% additional remuneration and the TA/DA at the rate as applicable to the Chief Engineer or equivalent shall be applicable.

**C) General Terms and Conditions for Chairperson and Independent Member:**

- 1. Last date of receipt of application: 18/07/2025.**
- 2. Applicant shall provide up to five preferred locations to work as a Chairperson/Independent Member**
- 3. Selection Process for the Post of Chairperson and Member,**
  - a) If necessary, selection process may be on basis of interview to be conducted by Maharashtra Electricity Regulatory Commission.
  - b) Prescribed qualifications are minimum and mere possession of the same does not entitle the candidate for selection.
  - c) Canvassing in any form will disqualify candidature.
  - d) If any false/incorrect information furnished by the candidate is detected at any stage of recruitment process, his/her candidature will not be considered.

- e) If the candidate knowingly or wilfully furnishes incorrect or false particulars or suppresses material information, he/she will be disqualified and if appointed, shall be liable for dismissal without any notice or assigning any reasons whatsoever.
- f) The decision of the MERC in all matters relating to recruitment shall be final and no individual correspondence will be entertained.
- g) The Commission shall verify the integrity and background of the applicants.
- h) **The Commission may select the candidate for one of the locations specified by the applicant or any other vacant position, based on the discussion during the interview/appointment process.**
