- (ii) With five (05) years' regular service in the posts in Level-10 of the Pay Matrix (Rs. 56100-177500) [Pay Band 3 (Rs 15600-39100) with Grade Pay 5400/- (Rs 8000-275-13500)-Pre Revised)];or
- (iii) With eight (08) years' regular service in the posts in Level-7 of the Pay Matrix (Rs. 44900-142400) [Pay Band 2 (Rs 9300-34800) with Grade Pay 4600/- (Rs 6500-200-10500)-Pre Revised)]

(II) Eligibility conditions for the post of Assistant Executive Engineer (Civil/Electrical)

Civil Engineering/Electrical Engineering Officers under Central Government/State Government/Union Territory Administration; and

(i) Holding analogous posts; or

(ii) with three (03) years' regular service in the posts in Level-7 of the Pay Matrix (Rs. 44900-142400) [Pay Band 2 (Rs 9,300-34,800) with Grade Pay of Rs. 4600/- (Rs 6500-200-10500-Pre-revised)]

(III) Eligibility conditions for the post of Junior Engineer (Civil)

Only officers of the Central/State Government departments, Statutory/Autonomous Bodies/Organisations/Public Sector Undertakings under the control of Central Government/State Government; and

- (A)(i) Holding analogous posts on regular basis; or
 - (ii) With three (03) years' regular service in the posts in Level-6 of the Pay Matrix (Rs. 35400-112400) [(Rs 9300-34800) with Grade Pay of Rs. 4200/- in PB-2 (Rs 5000-150-8000) pre-revised] or equivalent; and
- (B) Possessing the following educational qualification and experience
 Diploma in Civil Engineering from an institute/Board recognized by the Central Government or equivalent qualification

Note: Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation/Department of the Central Government shall ordinarily not exceed three years.

- 3. General terms & conditions of deputation in Employees' Provident Fund Organisation
- (i) The deputation will be governed as per the instructions issued by the Department of Personnel & Training from time to time as per the provisions of the Recruitment Rules of the respective cadre and the tenure of deputation will be initially a period of three (03) years and extendable as per DoP&T guidelines. The matter of pay and allowances will be governed strictly by the orders of the Central Government for such comparable posts. Preference will be given to the officers whose pay and allowances are governed by the Central Government rules including GPF Rules. The candidates should be holding the analogous post on substantive basis. Deputation allowance shall be admissible as per DoP&T guidelines only. The appointment in Employees' Provident fund Organisation will be further subject to acceptance of the terms and conditions of appointment issued by the Employees' Provident fund Organisation, if found necessary. The maximum age limit of the applicant should not be exceeding 56 years as on the closing date of receipt of applications.
- (ii) In case the selected official seeks repatriation before completion of two years on deputation, no transfer TA/DA will be paid on repatriation. Further, if official seeks repatriation within one year or less, Transfer TA/DA already paid, if any is also liable to recovered.
- (iii) A note shall also be added stating clearly how the candidates finds himself/herself suitable for the post. Preference may be given to the candidates possessing experience in preparation of estimates, planning and designing of civil/electrical engineering works.
- (iv) The Organisation has assets in the form of land and building. The nature of duties and responsibilities of various Engineering posts in the Organisation requires supervision of physical assets in the form of land & office building and their maintenance including monitoring of running projects will be essential duties on need basis. Touring might be needed to monitor outstation projects. For Junior Engineer (Civil), experience in estimation, drawing & design will be preferred.

- (v) The officer/officials shall be posted in the Zonal Offices/Regional Offices/Special States Office under the overall jurisdiction of Zonal Addl. Central P.F. Commissioner as per administrative exigency requirement.
- (vi) Willing and eligible officials must neatly fill **Annexure-I** of this advertisement and shall forward the same alongwith the application through proper channel to EPFO. A note shall also be added starting how the candidate finds himself/herself suitable for the post.
- (vii) The **Cadre Controlling Authority** shall forward the application complete in all respect with requisite documents namely **last 5 year APARs**, Annexure-I, duly filled in Certificate [Annexure-II], latest Vigilance Clearance Certificate within **60 days** from the date of publication of the advertisement.
