National Health Mission – Tamil Nadu is seeking applications from eligible candidates for Two position of Finance Analyst for its State Programme Management Unit at Chennai, Tamil Nadu.

#### Background

National Health Mission Tamil Nadu (NHM-TN) has been established to assure universal access to equitable, affordable and quality health care services which are accountable and at the same time responsive to the needs of the people and work towards attaining the SDH goals of health index.

#### Objective

As a Finance Analyst, the overall objective is **to take follow up action on the Monthly Concurrent Audit Report of All the 37 District Health Societies and State Health Society** under National Health Mission – Tamil Nadu.

#### Key Responsibilities

- To check whether the concurrent auditors furnish their monthly audit report to the concerned districts and State Health Society on or before 15<sup>th</sup> of the subsequent month.
- To Scrutinise the Monthly Audit Report of the Concurrent Audit Reports and bring it to the notice of the MD on the major observations.
- To communicate the observation of the Concurrent auditors report to the concerned District Health Officers / Joint Director of Health Services / Deans of Govt. Medical Colleges / District Program officers of Vertical Societies.
- Collect the ratification report from the District Audit Committee of the concerned Districts.

- To communicate the ratification reports received from the District Audit Committee and forward the same to Concerned Concurrent Auditors to rectify the queries.
- To collect the minutes of the periodical meeting of the District Audit Committee.
- To arrange for the conduct of Quarterly Debriefing Meeting of the Concurrent Auditors at the State Level duly communicating the fact of rectification report to all the concurrent auditors.
- Any other responsibility that may arise from time to time.
- He / She shall maintain a diary of activities performed by him / her each day and submit it to the Controlling Officer once in a week.

## **Output**

Timely accomplishment of task and responsibilities, regular reporting, provide situational analysis, achieve key deliverables and provide support to strengthen and implement key elements of the Programme assigned.
