1. These vacancies are provisional and may increase or decrease subject to the actual requirement for patient care and NMC requirement. The Competent Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice in the interest of patient care.
2. *Candidates with experience as Associate Professors may also apply for the post of Professor. Such candidates will be considered only if no eligible candidates with Professor-level experience attended or apply. However, if selected, they will be appointed at the pay scale of an Associate Professor.*
4. The dates of walk-in Interview as mentioned against the department are final and no change will be made. The candidates have to make necessary arrangements by their own for attending the Walk- in Interview.
5. Reservations will be as per Govt. of India guidelines issued from time to time.
6. In case of non-availability of reserved category candidates in the post of Professor/Associate Professor/Assistant Professor, the vacancy may be filled up, for less than 45 days, under UR category for fulfilling the urgent requirement.
7. The eligibility criteria including the age, educational qualification and period of experience, as prescribed in the advertisement will be determined with reference to the date of Walk- in Interview.
8. As per ESIC Headquarters Memorandum No. L-11/12/3/2016/MC-Faridabad/MEC dated 22.01.2018 and L-11/12/3/2020/PG Basai/ME CEL dated 28.10.2020, to comply with phase wise minimum MCI requirements;
 - a) Candidate with eligibility for a higher post (Professor/Associate Professor) would be permitted to be interview against a lower post (Associate Professor/Assistant Professor)
 - b) In event of selection of such candidate, the candidate would be considered for the placement with suitable upgradation of the lower post as per eligibility; and recommendation of the selection board.
 - c) The upgradation would be temporary and limited to the tenure of the teaching faculty/until the appointment of regular faculty in the lower post.
9. Candidates intending to apply for multiple cadres in same department shall submit separate applications.
10. For vacancies in the Ophthalmology department, preference may be given to candidates with a fellowship in cornea.
11. As per NMC TEQ dated 14.02.2022 regarding "**Determination of equivalence of the qualification of DNB (Broad Specialties) with MD/MS and DNB (Super Specialties) with DM/M.Ch**" -The Diplomat of National Board (DNB) in broad specialty and super specialty qualifications when granted in a medical institution with attached hospital or in a hospital with the strength of five hundred or more beds, by the National Board of Examinations, shall be equivalent in all respects to the corresponding broad specialty (MD/MS) and super specialty (DM/M.Ch) postgraduate qualification, but in all other cases, senior residency in a medical college for an additional period of one year shall be required for such qualification to be equivalent for the purposes of teaching.
11. The experience should be recognized by the Medical Council of India or the statutory body concerned with the system of medicine as valid teaching experience for teaching posts and certificate thereof or any other valid proof in support thereof should be submitted and a certificate to this effect is to be submitted.

These remunerations are subject to revision whenever there is a change in the Dearness Allowance (DA) rates, as per the directives from the ESIC Headquarters Office, in accordance with the policies for Central Government Employees.

iv) **No Private Practice is allowed during the tenure of service in ESIC.**

d) Term of Contract:

i) The initial period of contract for faculty will be for 01 year, extendable every year up to a maximum of 03 years or 70 years of age, whichever is earlier, subject to satisfactory performance. Barring unsatisfactory performance the incumbent would serve the initial-first year of contract, independent of regular faculty joining during this period. However, the contract would be terminable on one month notice, on joining of regular faculty in the 2nd/3rd year of contract.

ii) The tenure in respect of Senior Residents (3 Yrs) on contract basis; the engagement will be initially for 01 (One) year extendable every year up to three years on satisfactory performance and conduct.

iii) The tenure in respect of Senior Resident (1 Yr) will be one year only.

iv) The Contractual engagement may be terminated / discontinued on either side giving one month prior notice to this effect without assigning reason.

v) Senior Resident is a tenure post. Individuals with previous experience in Senior Residency at Central or State Government institutions may have reduced tenure based on the duration of their previous service.

vi) Other terms and conditions will be applicable as issued by competent authority from time to time.

e) The following documents should be submitted at the time of Walk-in Interview:

i) Two copies of recent self attested passport size photograph.

ii) Self-attested copies of certificates and testimonials in support of proof of age (Date of Birth), Educational Qualification, Experience and Research papers, Publications etc.

iii) Original certificates and testimonials in support of proof of age (Date of Birth), Educational Qualifications, Experience and Research Papers, Publications, PG Course recognition Certificate etc., Should be submitted at the time of walk-in Interview.

f) Terms & Conditions:

1. In case, the selected candidate resigns, he/she has to serve one month notice period or have to pay one month salary.
2. Candidates selected to the post of Professor/Associate Professor/Assistant Professor and Senior Resident have to deposit an amount Rs.100000/- as security deposit at the time of joining. The security deposit will be forfeited in case;
 - a) The selected candidate resigns/leaves within 01 year except Senior Resident (1 Yr).
 - b) The selected Senior Resident (1 Yr) resigns/leaves within 06 months from date of joining.
 - c) The selected candidate resigns/leaves after 01 year/ 06 months (as the case may be) of joining but fails to fulfill the Notice period conditions.
3. As the contract being for one year, absence for the period of 15 days or beyond without prior permission/approval of Competent Authority will be treated as abandonment of duty and the contract will be terminated without any notice and security deposit will be forfeited.
4. The absence from work for a period of fifteen days without proper permission of the Competent Authority will amount to voluntary abandonment of engagement and automatic termination. The Medical Officers are required to mark attendance manually as well as on NMC Face Aadhar Enabled Bio-metric Attendance System (Face AEBAS) daily during scheduled working days.
