- 6. For Hematopathologist, he/she shall have mastery in reporting hematopathology related investigations and shall be responsible to report all flow cytometry based investigations.

As per NMC TEQ dated 14.02.2022 regarding "Determination of equivalence of the qualification of DNB (Broad Specialties) with MD/MS and DNB (Super Specialties) with DM/M.Ch" -The Diplomat of National Board (DNB) in broad specialty and super specialty qualifications when granted in a medical institution with attached hospital or in a hospital with the strength of five hundred or more beds, by the National Board of Examinations, shall be equivalent in all respects to the corresponding broad specialty (MD/MS) and super specialty (DM/M.Ch) postgraduate qualification, but in all other cases, senior residency in a medical college for an additional period of one year shall be required for such qualification to be equivalent for the purposes of teaching.

The candidates seeking reservation under OBC category should submit OBC (Non-Creamy Layer) Certificate based on the income of the Financial Year (FY) 2022- 2023, 2023-2024 and 2024-2025 and issued on/after 01.04.2025 and shall be issued by an officer not below the rank of Sub-divisional officer or equivalent authority of the concerned state for central Govt. d) Term of Contract:

- i) The initial period of contract Super Specialist will be initially for a period of 01 year, extendable every year up to a maximum of 03 years **or** Up to attainment of 75 years of age for Super Specialist (Full time) **or** until joining of regular incumbent, whichever is earlier, subject to satisfactory performance.
- ii) The Contractual engagement may be terminated / discontinued on either side giving one month prior notice to this effect without assigning reason.
- iii) Other terms and conditions will be applicable as issued by competent authority from time to time.

e) The following documents should be submitted at the time of Walk-in Interview:

- i) Two copies of recent self attested passport size photograph.
- ii) Self-attested copies of certificates and testimonials in support of proof of age (Date of Birth), Educational Qualification, Experience and Research papers, Publications etc.
- iii) Original certificates and testimonials in support of proof of age (Date of Birth), Educational Qualifications, Experience and Research Papers, Publications, PG Course recognition Certificate etc., Should be submitted at the time of walk-in Interview.

f) Terms & Conditions:

- 1. In case, the selected candidate resigns, he/she has to serve one month notice period or have to pay one month salary.
- 2. Candidates selected to the post of Super Specialist (Entry Level) have to deposit an amount Rs.100000/- as security deposit at the time of joining. The security deposit will be forfeited in case;
- a) The selected candidate resigns/leaves within 01 year.
- b) The selected candidate resigns/leaves after 01 year of joining but fails to fulfill the Notice period conditions.
- 3. The selected specialist must have a professional indemnity policy which should cover the period as desired by ESIC. The policy is meant to cover the professional liability falling on them as a result of errors and omissions committed by them while rendering professional services. The minimum sum assured per annum should be
 - i.Rs 30 lakhs: Anesthesiologists, Cardiac Surgeons, Neuro Surgeons, Plastic Surgeons etc.
 - ii.Rs 20 lakhs: for General Surgeons, Gynecologists, and Obstetricians etc.
- iii.Rs 10 lakhs: for Physicians, Dentists, Radiologists, Pathologists, Chest (Pulmonologists) etc.
- iv.A copy of the Insurance & Premium Receipt must be submitted within 7 days from the date of engagement.
- 4. As the contract being for one year, absence for the period of 15 days or beyond without prior permission/approval of Competent Authority will be treated as abandonment of duty and the contract will be terminated without any notice and security deposit will be forfeited.
- 5. The absence from work for a period of fifteen days without proper permission of the Competent Authority will amount to voluntary abandonment of engagement and automatic termination. The Medical Officers are required to mark attendance manually as well as on NMC Face Aadhar Enabled Bio-metric Attendance System (Face AEBAS) daily during scheduled working days.

i) Selection Procedure:

- i) The selection will be made on the basis of performance of the candidate in the interview before the Selection Board.
