Note: i) Penalty for wrong answers:-

- a) There will be four alternatives for the answer to every question. For each question for which a wrong answer has been given by the candidate, **one-fourth** of the marks assigned to that question will be deducted as penalty.
- b) If a candidate gives more than one answer, it will be treated as a **Wrong Answer** even if one of the given answers happens to be correct and there will be same penalty as above to that question.
- c) If a question is left blank, i.e no answer is given by the candidate, there will be **no penalty** for that question.
- ii) The answers are to be encoded in the OMR Answer Sheet by Black Ball Point Pen only.
- iii) The persons with benchmark disabilities will be allowed "Compensatory time" of 20 minutes per hour.
- iv) The persons with benchmark disabilities and the condition mentioned at Para (IV) of Office Memorandum of Government of India F.No.34-02/2015-DD-III,dated:-29th August,2018, intending to avail facility of **scribe** will have to inform the Commission at least 07(Seven) days prior to commencement of the examination.

If a candidate fails to submit such representation at least 07(Seven) days prior to commencement of the examination, Commission will not be in a position to arrange **Scribe** for him/her.

Provisional Answer Key of Written Examination will be uploaded on the website of TPSC on completion of the Examination.

i. Mobile Phone/Electronic Gadgets etc. are banned in the campus of the Examination Premises/Interview Premises. Any Phone/Electronic Gadgets found in possession of any candidate in the Examination Premises/ Interview Premises shall be confiscated forthwith and he/she may be debarred from appearing at the Examination/Interview and also for the Examination(s)/Interview to be conducted by the Commission in future. Violation of such instruction will be dealt as per Law.
